**Important Note**

We are here to serve you online. The online system extends the hours of availability, but will not be available during maintenance periods. Payment information may also not be available at certain times due to additional system maintenance activities. If your transaction has a due date associated with it, it is your responsibility to ensure that your payment is made by that due date. Delays caused by unavailability of any online service DOES NOT warrant the reversal of late fees.  
\*Most mobile devices can be used to pay your taxes. Older devices may not work properly due to outdated technology. If you experience an issue using Safari as your browser, please use Chrome.

**Please Note:** Convenience fees for payments are collected in a separate transaction in accordance with the applicable fee schedule. In addition, New York State law mandates that the Town of Oyster Bay does not receive any portion of the convenience fee - this fee is retained by the payment processing vendors enabling the transaction. \*Please note that payments via the website are final and not reversible. \*Please use caution when entering online payments.

Email reminders will be sent according to the following notification schedule:

- 1. When tax amounts first become available and tax bills are being printed (October for School, January for General).**
- 2. Ten days before due date**  
*Feb. 1<sup>st</sup>, May 1<sup>st</sup>, Aug. 1<sup>st</sup>, Nov. 1<sup>st</sup>*
- 3. After due date, if payment is not received, reminders will only be sent if you have not paid your tax bill.**

Please note: This service is a courtesy only; the Receiver of Taxes is not responsible for any undelivered emails. Property owners are responsible for payment of all tax bills in a timely manner whether or not reminder notices are received.

The Town of Oyster Bay has been offering residents the opportunity to view their tax bill online, and we are proud to say that thousands of residents have taken advantage of this feature. The first of its kind in the United States, this system has a verification/validation system to ensure accuracy. For a service fee, residents can also pay their taxes online (a fee is charged by the provider to make credit card, debit card and ACH check payments. The Town of Oyster Bay receives no portion of this fee).

A great feature of this online system is that when residents sign up to view their taxes and opt in to receive email notifications, the Receiver's Office will send you a friendly and timely email reminder shortly before the date your tax payment is due.

To sign up for this service, log onto the Town's website, [www.OysterBayTown.com](http://www.OysterBayTown.com), and click on "View and Pay Your Taxes Online."

We hope you take advantage of this feature, just one more way the Town of Oyster Bay is hoping to make paying your taxes more convenient.
